Subject: Fanter Farms Environmental Assessment and promised opportunity to comment on Environmental Assessment prior to FONSI determination.

Dear Mr. Puccetti:

I am writing to you on behalf of the community located near the proposed location of the Fanter Farms hog facility in Mason County, Illinois. As a community, we are deeply invested in preserving our public health, environment, and protection of our only source of water, the Mahomet sole source aquifer. Recently we obtained over two hundred signatures on a petition regarding the inappropriate siting of a hog CAFO in our area.

The purpose of this letter is to request that the FSA Illinois State Office honor their assurances to the local community that we would have an opportunity to review the complete Environmental Assessment prior to any final decision made on the financing of the proposed Fanter Farms hog facility in Mason County near Peterville.

On Friday, October 1, 2021, we learned that the FSA had announced a Finding of No Significant Impact (FONSI) along with a completed Environmental Assessment. This announcement shocked the community that has been working with John Gehrke and the FSA offices these past few months because we were assured by Mr. Gehrke that we would have an opportunity to submit comments on the EPA review before the FSA made their final determination.

During the original public notice, the FSA had provided us with a draft and incomplete Environmental Assessment for our review and public comment. Our community members submitted numerous and substantial comments on the items in the assessment that were available for review. The item regarding impacts to the Mahomet sole source aquifer was blank because Mr. Gehrke was waiting for a response from the USEPA. We were assured by Mr. Gehrke that the public comment period would be left open until the response was received and incorporated into the Environmental Assessment. We have been waiting for weeks to hear from Mr. Gehrke and have called his office numerous times without response.

See Attachments 1 through 6 at the end of this letter where I have collected various email communications between Mr. Gehrke and either myself or Karen Hudson that

illustrate the promise that the public comment period would remain open until the EPA report was received and the community had the opportunity to submit public comments on that portion of the Environmental Assessment.

During that time from June to September, our community continued to submit vital information to Mr. Gehrke about the threatened habitat of the Chorus Frog. I have spent a significant amount of time working with state agency experts on endangered species to set up a field inspection in the vicinity of the proposed hog farm so that the FSA would have current and vital information to address in their Environmental Assessment. Mr. Gehrke is well aware of my considerable efforts on behalf of the Chorus Frog and my pleading to wait for the state to do their field inspection.

Today (October 6, 2021) we find ourselves cut out of the promised opportunity to submit public comments on the complete Environmental Assessment. Even more troubling is the discrepancy between the dates on the FONSI and Environmental Assessment and the time period in which we were waiting on Mr. Gehrke to signal he had received the EPA review of the Mahomet sole source aquifer.

3. email claiming the process is not completed yet --- Wed September 22, 2021 process not complete because public notice is needed.

4. no public notice has occurred in the Mason Democrat.

We respectfully request that the FSA deliver on their promise to our community to allow for public comment on the completed Environmental Assessment and that the FSA will give careful consideration to those public comments before finalizing their FONSI and providing Fanter Farms with financing.

To that end, we would like two weeks to evaluate the Environmental Assessment and submit formal public comments to the FSA. Thank you for your consideration in these important matters of public transparency in the federal financing of Fanter Farms.
